vii. Floats & Docks

1. Emerson passed on a report of damage from HM Campbell to the ramp at the PH float occasioned by the failure of three boat owners apparently to heed warning to remove them from the float in anticipation of serious storm conditions. According to Emerson¹, Campbell plans to beach two of the floats and reorient the third at right angles to the ramp (after it is repaired and re-installed). The tide cycle in the new location will mean that larger vessels will be forced to use their own moorings. A decision on whether to charge the boat owners for the damage remains on the table.

xi. Knox County

1. The 2017 county budget is final. NH assessment/fees will decline by 6% (\$27K). The change is the result of the drop in NH valuation. The KC budget is actually up 2.5%.

xii. Sheriff's Dept:

1. We are in receipt of data from Lauren Stuart at Maine Highway Safety Department identifying two vendors whose "breathalyzer" products meet state specs. The cost of an "intoxilyzer" is \$7K. The data from Stuart includes statutory requirements for regular testing and calibration. As previously reported, there is no grant money available to assist in purchasing one for the deputy's use.
