7. Old Business:

- a. *Airstrip*: The Town staff is continuing to develop options for the Board’s preliminary review.

8. New Business:

- a. *Pulpit Harbor* — The Select Board met with four representatives from the North Haven Conservation Partners (NHCP), Badge Blackett, President, Pat Curtis, Secretary, Jeff Crawford, Member, and Nibs Nichols, Executive Director. The purpose of the meeting was to discuss NHCP’s decision to purchase the property adjacent to the Town Pier in Pulpit Harbor. Badge said NHCP decided to purchase the property for four reasons: (1) it is adjacent to other NHCP’s property; (2) the land can serve as the terminus of an NHCP trailhead; (3) the area is one of the most scenic on the island; and (4) if the NHCP did not purchase the land, the land would have likely been purchased for the purpose of constructing a private home, and therefore would have no longer been accessible to a broader group of islanders and visitors.

During the meeting, it became obvious that both the Town and the Conservation Partners want to work together to address the parking issues and congestion along Pulpit Harbor Road. The Conservation Partners have agreed to engage a landscape architect to design a better looking a more functional parking area that would hold about a dozen vehicles. The Select Board will meet with the Conservation Partners and the landscape architect to view the architect’s proposals and discuss options.

The Town remains committed to providing waterfront access to everyone, including fishermen, aquaculturists, and recreational users. The Conservation Partners share this view. The State will soon hire a contractor to perform a resiliency analysis of the Town Pier. Both the Select Board and NHCP expressed a desire to work with the contractor to determine how best to control erosion and

to stabilize the shoreline.

The Conservation Partners also want the Town to know that NHCP would facilitate the construction of a fishermen's wharf in Pulpit Harbor. This would be a significant undertaking that would require interested fishermen to form a cooperative (or similar organization) and then obtain the funding to construct and maintain the wharf. The Conservation Partners have offered to assist the fishermen with such a project, but Badge Blackett noted that while the Partners were committed to providing an opportunity for the fishermen to build a wharf — whenever the timing might be right for that — the Partners were not in any way requiring the construction of a wharf.

- b. *Jerry M. White* — Jerry submitted his resignation from the Select Board effective Saturday, March 9, 2019, the day of Town Meeting

9. Board Member Comments: Curtis recommended Lattimer have the Town Attorney review the Town's easement at Pulpit Harbor. Lattimer agreed.
