- **a.** *Granite Disposal:* Board concurred that in consultation with Elliott Brown, it would sponsor public access on a date to be determined when interested parties could view and select granite left over from the bridge construction. The Town intends to charge \$30/CY for the granite, although the new eldercare facility will not be charged for any granite it selects. Any cutting and hauling charges will be the responsibility of the purchasers. At this writing, the Town has commissioned the use of some of the granite to border the water side of the PH parking lot.
