6. Reports:

- a. Administrator:
 - i. Clinic Awaiting roof and ceiling work to commence
 - ii. Fire Department/EMS
 - Fire Station Peter Flewelling, representative from Essex Steel, is working on a rough estimate of the cost of building a new fire

station using a prefabricated steel shell. The structure would serve as a Fire Station, EMS Station, and Plow Truck Building

- iii. Floats and Docks The Island Institute approved the Town's \$10,000 grant application for funds to support a working waterfront analysis and additional grant writing. We are awaiting the formal letter.
- iv. Legal George and Martha Neale have offered to donate shore land on Fresh Pond to the Town. Tammy Brown continues to work with the Town's attorney to determine the best way to proceed.
- v. Roads & Bridges
 - Lattimer is working on agreements for additional parking along Smith Street
 - State DOT may begin repaying Main Street as soon as August 21st; the paying will likely include the ferry terminal parking lot

- viii. Town Properties The position remains open
- ix. Transfer Station Lattimer found a firm that would hold a hazardous waste cleanup day at the Transfer Station during which residents could turn in hazardous waste for collection and proper disposal. The firm estimates the one-day event would cost between \$7,500 and \$10,000. The Board asked Lattimer to see if he could find less expensive firms or a less-expensive alternative that would still ensure the waste is properly disposed of.

7. Old Business:

- a. *Airstrip*: Lattimer met with the Town's attorney and with the engineering firm Gartley & Dorsky to discuss next steps in pursuing an alternative site for a town airstrip. He is awaiting more information.
- b. Summer Meeting to Discuss Town Priorities: The meeting is set for Sunday, August 18, 2019 at 4:00 pm at Turner Farm. Lattimer is working with the Town staff on a presentation. The Board worked with Lattimer to outline a plan for the presentation.

8. New Business:

a. Town Office Roof - Lattimer discussed a bid for putting a new roof on the Town Office. The Board asked Lattimer to find out if the bid would be lower if: (1) the screws in the metal roof would be visible instead of hidden; and (2) if asphalt shingles were used instead of a metal roof.

- b. *CPR Training at Community Days* Lattimer notified the Board that EMS Crew Chief, Erin Cooper, intended to offer free CPR training during Community Days. Participants in the training would be free to donate to North Haven EMS if they wished. Cooper hopes to raise funds to purchase a new AED device.
